
Dear Ms. Kimbell:

On behalf of the 23 state, provincial, and territorial wildlife agencies comprising the Western Association of Fish and Wildlife Agencies (WAFWA), please accept this letter and attached report entitled "*Recommendations for Domestic Sheep and Goat Management in Wild Sheep Habitat*". This report was first transmitted to WAFWA directors by its Wild Sheep Working Group (WSWG) on June 21, 2007, with a final presentation given by Chair Kevin Hurley at the annual business meeting on July 12, 2007, in Flagstaff, Arizona. The report was unanimously endorsed by the directors at that time.

WAFWA is in the process of forwarding this report to federal land management agencies that currently or potentially manage domestic sheep and goats in wild sheep habitats on federal lands. This WAFWA-endorsed report represents our association's official position on this issue. We recommend that this report, and the recommendations included herein, be used as the basis for creation or revision of policy-level direction in your agency.

WAFWA member agencies look forward to our continued involvement with our federal land management partner agencies. We appreciate all that the Forest Service, in particular, has done to date on management of domestic sheep and goats in wild sheep habitat, and we look forward to collaborating more in the future.
