Call For Papers

The theme of the 2019 Desert Bighorn Council Meeting is *Beyond Borders: Collaborative management recognizing connectivity, disease, and genetics*. With the advent of GPS collars, improved scientific methods in Epidemiology and Genomics, and recent disease events that cross multiple state and federal jurisdictions, we all have realized the reality of our broad southwest desert landscapes where bighorn sheep know no boundaries and neither should we when it comes to collaborative bighorn research and management.

In support of this year's theme, a special session will involve an interactive presentation and discussion on information we have all been busy collecting the last few years on disease surveillance, herd genomics, and herd demographic performance in relation to disease events. This special session will be like the regional workshop held in Laughlin 2014 with all the southwest state agencies and NPS units attending to share their stories and information on the recent disease events that had spread across 3 states and multiple NPS units. Mike Cox will be reaching out to each jurisdiction and sending out a survey in late February for everyone to fill out as part of the special session presentations and discussions.

Please identify if the abstract will be an oral or poster presentation and the name of the presenter immediately after the abstract.
